- Participants must be between the ages of 5 to 7 years old, a Union County resident and attend a Union County school. Entry fee is \$25, and every participant will receive a tiara and sash.
- **Entry deadline for the Princess Program ONLY will be August 15th, 2022.** All other age groups must enter by August 1st, 2022.

Entries can also be turned into the pageant the director anytime before or by August 15th. On August 15th, the entries can be turned in at the Anna Elks from 5:30-7:00pm.

- **ALL** entries must be received and in the pageant director's possession by the 15th, **NOT** postmarked by the 15th.
- **There will be a meeting and short practice on Thursday, August 18th at 5:15-6:00pm at the Anna VFW.**
- Princess participants can wear a sundress or a knee length holiday type dress or a high/low dress. **No long floor length gowns please.**

Princess participants will walk on stage, have their name and a short bio read while on stage and then they will be asked what they want to be when they grow up. No judging will take place. All Princess Participants will be "crowned" on stage. After the group has been crowned, they will be dismissed and at that time parents will collect their Princess and the pageant will continue with the Little, Junior and Miss competing. Once dismissed the Princesses are done for the evening.

Releases and forever discharges the Executive Board of the Union County Fair Association and the Pageant Directors, shareholders, affiliates, agents, representatives, successors and assigns (collectively the "Releases") of and from all liability, claims, demands, damages, costs, expenses, actions, and causes of action (collectively the "Claims") in respect of death, injury, loss, or damage to myself or property, howsoever caused, arising, or to arise by reason of or during my participation in the Union County Fair Queen Princess Program or pageant related events, whether prior to, during, or subsequent to my attendance, and notwithstanding that any Claim may have been contributed to or occasioned by the negligence of any of the Releases.

4. Understands and acknowledges that the Releases do not carry or maintain health, medical, accidental, or disability insurance coverage for the entrant, and therefore agrees to assume responsibility for such insurance coverage on the undersigned if the need should arise.
